




NOW THIS INDENTURE WITNESSETH AS FOLLOWS:

- In order to effectuate its said desire the AUTHOR has handed over to the Trustees a sum of Rs.10,000 (Rupees Ten Thousand only) to hold and stand possessed for the same (hereinafter for brevity's sake referred to as "Trust Fund" which expression shall also include cash and any other property and investments of any kind whatsoever into which the same or any part thereof might be converted, involved or varied from time to time or such as may be acquired by the Trustees or come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents) upon the Trust and with and subject to the powers, provisions, agreements and declarations hereinafter declared and contained of and concerning the same.

- (3) The object for which Trust Fund is established is to promote education, healthcare, gender equality initiatives, development of water resources, training and assistance for employment oriented / entrepreneurial. / self, help ventures and advancement of any other charitable objects of general public utility not involving the carrying on of any activity for profit and for such purposes.
 - (a) To establish maintain, and/or grant ald inn cash and/or kind to hospitals, imedical schools, medical colleges, inursing institutions, veterinary hospitals charitable and/or traveling dispensaries, aftercare clinics maternity homes, child/welfare/centres; orphanages, widows homes and/or such other similar charitable institutions in India for the benefit and use of the public in general.
 - (b) To establish support acquire, run and/or grant aid and other financial assistance. (c) rechools, colleges, libraries reading rooms, hostel, boarding nouses, laboratories and other institutions of like nature at any place or places in the Indian Union for use of the students and the staff and also generally for the development and/or advancement of education and diffusion of knowledge amongst the public in general.
 - (c) To establish, maintain and/or run studentships, scholarships and render other kind of aid to individuals including supply of medicines, books, stipends, medals and other incentives to study, without any distinction caste, colour or creed.

- (d) To grant aid, to promote, establish, support, and/or maintain institution for the preservation of Science, Literature, Music, Drama and Fine Arts, and other institution having similar objects for the benefit of the public in general.
- (e) To establish and/or grant aid for the establishment and maintenance of parks and gardens, gymnasiums and sports institutes, choultry / dharamashalas, tubewells, wells and water works for supply of drinking water and for the construction of and/or repairs to wells for the use of public in general.
- (f) To establish, maintain and grant aid to homes, orphanage or other establishments for relief and help to the needy, the poor and destitute people, orphans and widows.
 - To provide help to the needy, the destitute, the physically handicapped and the poor without any distinction of caste, colour or creed.



- The Trustees shall cause true and acdurate accounts to be kept of all moneys received and spent and of all matters in respect thereof in course of management of Trust properties of in relation to the carrying out of the objects and purposes of the Trust as well as of all assets, credits and effects of the Trust properties.

(d) To invest and keep invested the Trust Fund either in the purpose of mortgage of immovable property or in shares, stock or debentures or other securities and investments, or in deposits with or loans to any Company including Shree Renuka Sugars Ltd. Author hereof, bank, firm and any other persons, and to alter, vary or transpose such investments from time to time as the Trustees may, at their discretion think fit for others of the same or of like or different.

To borrow or raise or secure payments of moneys and also to lend money either with priviling security.

To sell, dispose of alienate or otherwise deal with any property.

(g) To liet out, demise any immovable property comprised in the Trust Fund for such period and at such rent on such terms and conditions as the Trustees in their discretion may think fit.

(h) To ropen raccount, in the name of the Trust. Trustees and/or institutions run/conducted by the Trust with a Bank of Banks to operate such account and to give instructions to the bank and to provide for opening and operation of such account by one or more of the Trustees of Cylan agent appointed by the Trustees.

To adjust settle, compromise, compound refer to arbitration, all actions suits claims demands and proceedings regarding the Trust Fund

To appoint constituted attorneys or agents and to delegate to such attorneys or agents all or any of the powers vested on them under these presents and from time to time remove such attorneys or agents and to appoint other or others in his or their place.

(o) To Join, co-operate or amalgamate this trust with other or others having kindred or allied objects, upon such terms and conditions as the Trustees may in their discretion think fit, particularly having regard to and in conformity with the objects and nature of this Trust.

It shall be lawful for the Trustees to give all by way of conations out of the income of the corpus of the Trust Fund or otherwise to different charitable halfullons societies, organizations of Trusts in India which may have been established or which may hereafter be established for like charitable outposes mentioned in these presents or any of them to enable such institution, societies, organization or Trustees to start, maintain or carry out such charitable objects as are mentioned in these presents or any of them.

The Trustees will not be entitled to receive any remuneration, but the Trustees may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

The number of the Trustees shall not be less than two and more than seven. If the number of the Trustees shall fall below two, the Trustees shall not, except for the purposes of filling any vacancy, act so long as number is below the said minimum.

The Trustees for the time being with the consent of the Author will be at liberty to appoint additional Trustee within the number mentioned above, for such period or on such terms as to retirement and reappointment, as the trustees for the time being consider proper. If any trustee dies, retires, becomes unfit of incapable to act, the continuing or surviving Trustee or Trustees will be competent to appoint a Trustee in place of the Trustees dying, retling or becoming unfit or incapable to act with the consent of the Author. A person shall bease to be a Trustee either: (i) if he without leave of absence does not attend three consecutive meetings of the Trustees or for one calendar year, whichever is longer or (2) if he is requested to resign by 3 4th or as near thereto as possible of the remaining Trustees.

- (13) The Trustees may from time to time frame rules for the conduct and regulations of the meetings of trustees. In the absence of such regulations;
 - (a) Two Trustees shall form a quorum for a meeting of the Trustees.
 - (b) All matters will be decided mutually by the Trustees.
 - (c) Resolutions passed without any meeting of the Trustees but by dirculation thereof and evidenced in writing under the hands of two-thirds of the trustees shall be as valid and effectual as a Resolution duly passed at a meeting of Trustees.
- (14) The Trustees shall have the power and their uncontrolled discretion, instead of acting personally, to employ and pay an agent (including any Bank) to transact any business or to do any act whatsoever in relation to the Trusts of these presents, including the receipt and payment of moneys without being liable for loss, and shall be entitled to be allowed and paid all charges and expenses incurred thereby.

The Trustees may delegate in writing all or any of his powers under these presents to his nominee, who will be entitled so long as such nomination remains in force, to exercise such power or powers, in the same manner as the Trustee himself could do personally.

- The Trustees shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out of income or capital any expenses or outgoings ought to be paid or borne and on every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
- (17) It shall be lawful for the Trustees to settle all accounts and to compromise compound; abandon, or refer to arbitration any action or proceedings of disputes, plain, demand, or things proper for such aurpose will out being responsible for any loss occasioned thereby.
